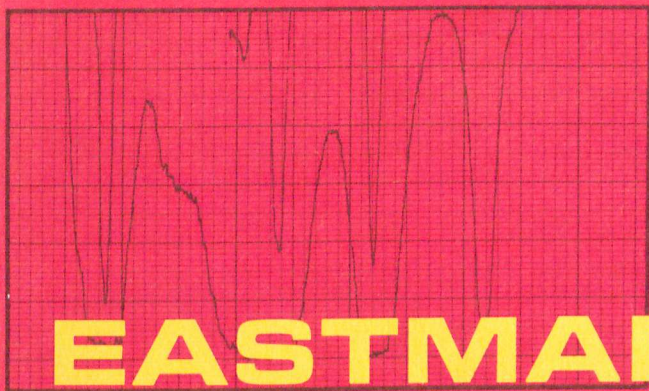
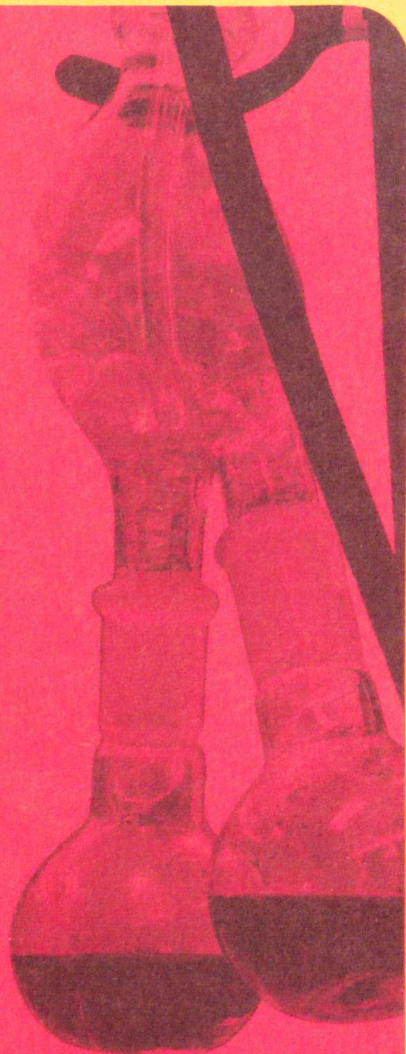

“FOR CHEMICAL PURPOSES, NOT FOR DRUG USE”

This statement appears on the labels of all EASTMAN Organic Chemicals. It signifies that the tests that they have passed are of a nature to establish their suitability for chemical work, but not to assure their safety in drug use.

Nor are the EASTMAN Organic Chemicals listed in this catalog intended or suitable for use in food. Other divisions of Eastman Kodak Company do offer recognized food additives.

Nor are EASTMAN Organic Chemicals intended or sold for household use.

A star (★) in this catalog marks chemicals which are 1) listed in the U.S.P. XVII or N.F. XII (except for reagent use) or 2) known to have a use as a drug as defined in the Federal Food, Drug and Cosmetic Act. For these chemicals, *shipment will be withheld* until written assurance is received from the purchaser that no drug use is intended. The suggested form is: “These chemicals will not be used for drug purposes or sold by us for such use.” It is further suggested that all orders for EASTMAN Organic Chemicals carry this statement when it truly represents the facts. This will avoid delay in shipment that would be necessary when chemicals are ordered that are not presently stocked but have been found to be of interest as drugs.

Chemicals which are to be used experimentally for screening purposes to determine their usefulness and safety as drugs or food additives will be supplied only when such tests are to be carried out in the laboratory and when no animals in which the chemicals are used (or products of such animals) will be used as food.
